

It is structured to support emerging national and state trends in safety and quality and provides the overarching framework through which the organisation implements and actions clinical excellence in our services.




The resulting framework is inclusive and represents recognised best practice principles that:

# BREAKTHROUGH FOR FAMILIES QLD (BFFQ)

#### ABOUT THE PROGRAM

Breakthrough for Families Qld is a person-centred support program for families and significant others impacted by another person's alcohol and other drug use.

Incorporating the latest evidence, the program is designed to equip family members and significant others with information and strategies to cope with the impact of substance use on the family, and care for the person using substances. Our Family Support Facilitators inform the community through public information sessions, and coach clients through individual or family sessions with a range of referrals and other supports.

The program enables clients to understand substance use, equips them with the skills and knowledge to navigate the treatment landscape, and addresses barriers to seeking help.

Participation in the Breakthrough for Families program is voluntary and the sessions are culturally respectful, accessible and inclusive.

#### **ACTIVITIES**

Breakthrough for Families Qld undertakes the following treatment activities:

- · Case Management
- Casework
- · Consultation and liaison
- Discharge planning
- · Treatment planning and review

#### ELIGIBILITY CRITERIA

- Information sessions are open to the public.
- Brief intervention is available to family members and significant others of people using substances

#### TREATMENT EPISODE

The duration of treatment is tailored to client's presenting issues.

#### INTAKE & ASSESSMENT

No intake is required for information sessions. Walk ins welcome

#### REPORTING OBLIGATIONS

Drug ARM has the same reporting obligations as other entities that are not Prescribed entities. Where there is an indication of harm to a child we will use the Child Protection Guide to determine whether to notify Child Safety or refer to a Family and Child Connect service.

BFFQ is not intended to bring families into the child protection system or to monitor families who are receiving assistance from the child protection system. This is to alleviate concerns among families with children that talking about substance use with Drug ARM may lead to an investigation by Child Safety.

# COMMUNITY CORRECTIONS COUNSELLING

#### ABOUT THE PROGRAM

Community Corrections Counselling is an outpatient, person-centred alcohol and other drug treatment service for people attending Community Corrections who are experiencing issues related to their substance use.

Incorporating the latest treatment evidence, the program is designed to motivate clients towards change. Our Case Workers coach and counsel clients with a range of best practice assessments, interventions, referrals and other supports.

The program enables clients to explore practical options to help manage their situation with a holistic focus on relapse prevention, coping strategies, relationship skills, anger management, emotional regulation, general health, mental health, and other life skills support. Our Case Workers can also provide support before, during and after undertaking other alcohol and other drug treatment programs (such as detoxification).

The Community Corrections Counselling program is delivered using a recovery framework and the bio-psychosocial harm minimisation approach to create sustainable change.

Community Corrections Counselling undertakes the following treatment activities:

- Brief intervention
- · Case management
- · Case work
- · Intake screening
- Counselling
- · Discharge planning, aftercare/continued care
- · Treatment planning and review

#### ELIGIBILITY CRITERIA

 Queensland Community Corrections referral

#### TREATMENT EPISODE

The duration of treatment consists of 6 or 12 weekly one-hour sessions.

This is determined by the referring Community Corrections Officer.

#### INTAKE & ASSESSMENT

All intake and assessment is conducted at the relevant community corrections site following referral.

#### RFFFRRALS

Clients must be referred to the program by Community Corrections using a referral form.

# COMMUNITY & FAMILY SUPPORT SERVICE (CAFSS)

FAQ for Service Providers. Separate information and marketing material is available for public distribution.

#### ABOUT THE PROGRAM

Community and Family Support Service (CAFSS) is a person-centred, outpatient alcohol and other drug treatment service and family support program for people who are experience issues related to their substance use, or the substance use of a family member or significant other.

Incorporating the latest treatment evidence, the program is designed to motivate clients towards change. Our Case Workers work in pairs to coach and counsel clients with a range of best practice assessments, interventions, referrals and other supports.

The program enables clients to explore practical options to help manage their situation with a holistic focus on coping strategies, relationship skills, anger management, emotional regulation, general health, mental health, and other life skills support. For people using substances, there is a strong focus on relapse prevention strategies and our Case Workers can also provide support before, during and after undertaking other alcohol and other drug treatment programs (such as detoxification).

The CAFSS program is delivered using a recovery framework and biopsychosocial harm minimisation approach to create sustainable change.

#### **ACTIVITIES**

CAFSS undertakes the following treatment activities:

- Brief intervention
- Case work
- · Intake screening
- · Consultation and liaison
- Counselling
- · Discharge planning, aftercare/continued care
- Treatment planning and review

#### ELIGIBILITY CRITERIA

- Low to moderate substance use
- Low to moderate health and lifestyle issues due to substance use OR
- Family member and significant others of people using substances
- Live within service location boundaries

#### REQUIREMENTS

- Withdrawal (detox) not required
- · Abstinence not required
- Smoking cessation not required

#### TREATMENT FPISODE

The duration of treatment consists of 12 weekly one-hour sessions for individuals and 4 weekly one-hour sessions for significant others.

Clients are able to engage in multiple treatment episodes.

#### ABOUT THE PROGRAM

Connect group is a person centred psychosocial education group for women incorporating the latest treatment evidence, designed to motivate participants for change. Connect supports participants with awareness raising and opening to the possibility of change concerning their substance use.

The Group enables participants to explore behavioural patterns, values, interpretations of events, and individual life outlooks by providing information, asking open-ended questions, developing rapport, and identifying stressors and treatment options.

Connect emphasises behavioural change and how to better understand and cope with feelings and motivations, encouraging participants to take responsibility for their actions.

- · Building and maintaining motivation to change
- · Alcohol and other drug awareness
- · Coping with urges and cravings
- · Think, feel, behave
- · Lifestyle balance
- Communication

Creating Options is a comprehensive person-centred outpatient alcohol and other drug treatment service for people who are experiencing severe and complex issues related to their substance use.

Incorporating the latest treatment evidence, the program is designed to motivate clients towards change. Our Clinical Workers coach and counsel clients with a range of best practice assessments, interventions, referrals and other supports including case formulation and coordination.

The program enables clients to explore practical options to help manage their situation with a holistic focus on relapse prevention, coping strategies, relationship skills, anger management, emotional regulation, general health, mental health, and other life skills support. Clinical Workers can also provide support before, during and after undertaking other alcohol and other drug treatment programs (such as detoxification).

Creating Options is delivered using a recovery framework and biopsychosocial harm minimisation approach to create sustainable change.

## DAY PROGRAM

FAQ for Service Providers. Separate information and marketing material is available for public distribution.

#### ABOUT THE PROGRAM

The Day Program is a person-centred, outpatient, non-residential alcohol and other drug rehabilitation treatment service for people who are experiencing issues related to their substance use. The program assists people that require more intensive community-based support than psychosocial interventions provide, but less intensive intervention than is provided in residential treatment.

Incorporating the latest treatment evidence, the program is designed to motivate clients towards change. Our Case Workers coach and counsel clients with a range of best practice assessments, interventions, referrals and other supports including case formulation and coordination.

The program enables clients to explore practical options to help manage their situation with a holistic focus on relapse prevention, coping strategies, relationship skills, anger management, emotional regulation, general health, mental health, and other life skills support. Through groups, the program also provides life skills development to support ongoing substance use management including relationships, parenting, housing, employment, assertiveness, mental health, anger management, nutrition and exercise, and conflict issues.

The Day Program consists of four phases: Pre-entry Phase (Pre-entry week), Intensive Treatment Phase (Weeks 1 - 8), Transition Phase (Weeks 9 - 12) and Sustaining Recovery Phase (Months 3 - 12).

The Day Program is delivered using a recovery framework and biopsychosocial harm minimisation approach to create sustainable change.

#### **ACTIVITIES**

The Day Program undertakes the following treatment activities:

- · Case Management
- Casework
- · Care coordination
- · Consultation and liaison
- · Discharge planning, aftercare/continued care
- · Information and education for clients in group settings
- · Integrated care with other support agencies
- · Peer support
- · Therapeutic groups
- · Treatment planning and review

#### FLIGIBILITY CRITERIA

- Moderate to severe substance use
- Moderate to severe health and lifestyle issues due to substance use
- · Adults aged 18+

#### REQUIREMENTS

- Withdrawal (detox) not required
- · Abstinence not required
- Smoking cessation not required
- · Phones permitted

#### TREATMENT EPISODE

Participants in the Day Program attend 20 hours per week, over a period of 12 weeks.

Participants are also required to complete a pre-entry appointment with the local team prior to commencing in the Day Program.

The Day Program is delivered in four week blocks, and intake is accepted at the beginning of each block

#### MANAGEMENT/ AFTERCARE

To complement face-to-face services, clients are provided an electronic tablet device to store information and worksheets on whilst participating in the program. Materials are loaded on the device at the commencement of the program and during the sessions.

Upon successful completion of the program, ownership of the tablet is transferred to the client. Successful completion of the program requires attendance at a minimum of 75% of sessions and agreement from the case worker.

# DRUG, ALCOHOL, ASSESSMENT & REFERRALS (DAAR)

FAQ for Service Providers. Separate information and marketing material is available for public distribution.

#### ABOUT THE PROGRAM

The Drug, Alcohol, Assessment and Referral program involves a single two hour session assessing the client's substance use, social supports, psychosocial issues and mental health, providing education regarding alcohol, anger management and mental health, and referrals to services which can provide further support.

#### REFERRALS

When an individual is identified either by police or the courts as being eligible for a DAAR Course:

- a DAAR course referral form is completed by police officers or court officers authorised by the Bail Act 1980 to grant bail for the individual's release
- the DAAR Coordination Service (DCS) is contacted to schedule an appointment
- the completed referral form is emailed to Diversion & Referral Services (D&RS), Courts Innovation Program, Department of Justice & Attorney-General.

The police officer or judicial officer must impose as a condition of release that the individual complete their DAAR course by a stated date, which is recommended as being within three months from the date of referral.

#### ELIGIBILITY CRITERIA

- · 18 years and over
- Charged with a prescribed offence and it is alleged that the offence was committed in a public place while the person was adversely affected by an intoxicating substance, including but not restricted to alcohol and illegal drugs
- Live within service location boundaries

#### REQUIREMENTS

- Withdrawal (detox) not required
- · Abstinence not required
- Smoking cessation not required
- · Phones permitted

#### TREATMENT EPISODE

Participants are required to attend a single two hour education session.

Explore group is a person centred psychosocial education group incorporating the latest treatment evidence, designed to motivate participants for change. Explore supports participants with awareness raising and opening to the possibility of change concerning their substance use.

The group enables participants to explore behavioural patterns, values, interpretations of events, and individual life outlooks by providing information, asking open-ended questions, developing rapport, and identifying stressors and treatment options.

Explore emphasises behavioural change and how to better understand and cope with feelings and motivations, encouraging participants to take responsibility for their actions.

- · Building and maintaining motivation to change
- · Alcohol and other drug awareness
- · Coping with urges and cravings
- · Think, feel, behave
- · Lifestyle balance

#### TREATMENT EPISODE

Explore is offered as a Short Intensity Program over 6, 12 or 24 hours or a Medium Intensity Program over 48 and 96 hours.

This is determined by the referring Queensland Corrective Services Officer.

#### INTAKE & ASSESSMENT

All intake and assessment is conducted at the relevant Queensland Corrective Services site following referral.

#### REFERRALS

Clients must be referred to the program by Queensland Corrective Services Officer.

## FAMILY SUPPORT PROGRAM

FAQ for Service Providers. Separate information and marketing material is available for public distribution.

#### ABOUT THE PROGRAM

Family Support Program (FSP) is an early intervention program to provide support for children, young people and families.

Incorporating the latest evidence and practice, the program works to improve the wellbeing and safety of children and their families, to help preserve families and to prevent entry or re-entry to the statutory child protection system. Our Case Worker provides individual case management and groups. The program aims to build the capacity of individuals, young people and their families to strengthen the family unit, cope with adversity, and overcome emotional and psychological harm caused by abuse or neglect.

Case Workers also work with young people to reduce pathways to adult disadvantage by intervening early to address problems that might arise. The program specifically targets children, young people and families who find themselves in vulnerable situations but are not currently subject to statutory child protection intervention.

The Family Support Program undertakes the following treatment activities:

- Case Management
- Casework
- · Consultation and liaison
- Counselling
- · Discharge planning
- · Groups
- · Treatment planning and review

#### ELIGIBILITY CRITERIA

Families determined 'at risk' of entering the statutory child protection system with children aged unborn to under 18.

Families currently in the child protection system are not eligible.

#### TREATMENT EPISODE

The duration of treatment is tailored to client's presenting issues.



# INTENSIVE FAMILY SUPPORT SERVICE (IFSS)

#### ABOUT THE PROGRAM

Intensive Family Support Service (IFSS) is an early intervention program to provide support for children, young people and families .

Incorporating the latest evidence and practice, the program works to improve the wellbeing and safety of children and their families, to help preserve families and to prevent entry or re-entry to the statutory child protection system. In partnership with Churches of Christ Qld, Drug ARM provides a specialist alcohol and other drug intervention for families engaged in IFSS.

Our Clinical Workers provide individual case management to families and help them to become stronger, more resilient and create safer spaces for children. Clinical Workers also work with families and young people to reduce pathways to adult disadvantage by intervening early to address problems that might arise. The program specifically targets children, young people and families who find themselves in vulnerable situations but are not currently subject to statutory child protection intervention.

#### **ACTIVITIES**

The Intensive Family Support Service undertakes the following treatment activities:

#### ELIGIBILITY CRITERIA

Families determined 'at risk' of entering the statutory child protection system with children aged unborn to under 18. Families currently in the child protection system are not eligible.

#### TREATMENT EPISODE

The duration of treatment is tailored to client's presenting issues.

#### INTAKE & ASSESSMENT

Intake can be conducted by telephone or online.

#### REPORTING OBLIGATIONS

Drug ARM has the same reporting obligations as other entities that are not Prescribed entities. Where there is an indication of harm to a child we will use the Child Protection Guide to determine whether to notify Child Safety or refer to a Family and Child Connect.

IFSS is not intended to bring families into the child protection system or to monitor families who are receiving assistance from the child protection system. This is to alleviate concerns among families with children that talking about substance use with Drug ARM may lead to an investigation by Child Safety.

## POLICE COURT DIVERSION (PCD)

FAQ for Service Providers. Separate information and marketing material is available for public distribution.

#### ABOUT THE PROGRAM

Police Court Diversion is an early intervention initiative to provide individuals apprehended for minor drug offences with an incentive to address their substance use early, potentially before receiving a criminal record.

The program delivers assessment, education and support to individuals who have been charged with possession of an eligible substance and have been offered a diversion on no more than one previous occasion (including Police Diversion).

The diverted individuals are required to attend and complete a two hour assessment and education session. Upon completion of the assessment and education session, clients are offered a referral to the closest available individual or organisation authorised to provide an evidence-based outpatient treatment program.

The program uses a harm minimisation approach and seeks to initiate change in offenders. The program also provides screening and referrals to individuals for a range of psychological and social concerns.

#### REFERRALS

Referrals can be made on the spot by police or through the courts.

This is not a voluntary program.

#### ABOUT THE PROGRAM

Street Outreach Service (SOS) is a mobile outreach program that supports individuals who are, or are at risk of, experiencing homelessness and who may have substance use issues.

Incorporating the latest evidence and practice, the program works to improve the wellbeing of people experiencing homelessness and other complex issues through harm minimisation, information, referrals and crisis intervention. Our volunteer outreach teams also provide transport, emotional support, connections to other agencies and health information.

Outreach Workers also work alongside patrol partners such as local health professionals including GPs to provide brief medical support, housing support, and other social and welfare services.

#### **SMART Recovery**

SMART (Self Management and Recovery Training) Recovery is a group program assisting any problematic behaviours, including dependency to drugs, alcohol, cigarettes, gambling, food, shopping, Internet and others.


Guided by our Clinical Workers, participants come to help themselves and help each other using a variety of cognitive behaviour therapy (CBT) and motivational tools and techniques.

The 4 Point program helps participants to enhance and maintain motivation, cope with urges, problem solve and build a healthy lifestyle balance.

#### **Wise Choices**

Wise Choices is a structured, 10 session psychoeducation group for people using substances experiencing symptoms of Borderline Personality Disorder.

The sessions introduce the basic Acceptance and Commitment Therapy (ACT) skills and focus on topics such as: difficult thoughts and feelings, acceptance and mindfulness skills, and personal values.




